AIIMSD Admission & Scholarship Test(AIIMSD-AST)

AIIMSD conducts AIIMSD Admission & Scholarship Test (AIIMSD-AST) before commencement of regular classes. The students can appear in it & get the benefit of scholarships. The Scholarship would be given to the students according to the performance of the students in AIIMSD- AST.

Eligibility

Students satisfying the following criteria can participate in AIIMSD-AST:

- An Indian Citizen
- A student studying in class 10th /12th in a recognized school of India

How to apply?

Eligible candidates can apply for the scholarship through the following steps -

Step 1: Go to online [link](#) and click on 'Apply online'

Step 2: Through Register Email account.

Step 3: Once signed in, click on 'Start Application' to start filling the form.

Step 4: Fill in all the details and upload /Send the required documents on email: - scholarship.aiimsd@gmail.com

Step 5: Finally, click on 'Submit'.

Note: On successful completion of Online Application Process, the applicants will receive a confirmation email/SMS on their registered email id/mobile number.

Remote aria Candidates can also apply offline and send the application to the Institute Address.

Ques.Age Limit?

- Ans.18-35 Year. Age relaxation for SC/ST/OBC & Woman Candidates as per Govt. Rules.

Ques. Application Processing fees (Non -refundable)?

- Ans: 200/-For Gen./OBC & 150/- for SC/ST Candidates- pay online through Net Banking, Debit/Credit Card, Paytm, Phone Pay or may also deposit cash directly in the Bank Account.

Ques. Study Material fees for Written Exam.?

- Ans: 150/- (Depends on the Candidates)

Ques . Last date of the application.?

- Ans. For January Session **25 October of every year** and for July Session **25 May every year**. Applications are invited twice a year. Candidates with relevant qualification shortlisted & will be called forcounselling or written test.

IMPORTANT NOTE FOR ENTITLEMENT OF SCHOLARSHIP

Students eligible for any scholarship being awarded must submit all the relevant documents at institute's office/fee counter to avail the benefits. Students failing to do so shall not be entitled for any benefits.

List of documents to be submitted for scholarship entitlement (As applicable for the head) :

- Class-X Mark Sheet
- Class-XII Mark Sheet.
- NTSE (Stage-I/II) Qualifying documents
- State Level Science/Talent Search Examination (Qualifying documents)
- Olympiad (Any stage) qualified (Conducted by HBCSE)
- Kishore Vaigyanik Protsahan Yojana-KVPY (Any stage) qualified
- Supporting documents for Scholarship awarded for old students, real brother/sister of AIIMSD alumnus and for scholarship for sibling's category
- Defense - Copy of dependent card
- NCC - Copy of NCC certificate

- ID proof .
- Income proof
- Aadhar card
- Proof of rank in competitive examination (if any)

TERMS & CONDITIONS

There are some terms & conditions to be fulfilled by the students to become eligible for above mentioned scholarships. They are:

- The scholarship is valid for one year only i.e. for academic session(Availed or Not availed).
- The scholarships shall be applicable to a student only after taking admission in respective program (at Kasganj/Authorized Study Centre of AIIMSD across India).
- Student can avail only best of one scholarship in case he/she is eligible for more than one scholarship under different criteria by AIIMSD through any other scholarship program.
- A student appeared in **AIIMSD-AST** and have taken admission in AIIMSD as stated earlier; shall not be allowed to appear in AIIMSD Final test on the basis of same enrolment number & his / her course fee shall not be transferred to any other course.
- The performance of a student in **AIIMSD- AST**&AIIMSD Final test is independent & the performance linked scholarships of both the tests cannot be linked and are non-transferable.
- **AIIMSD- AST**&AIIMSD Final test are independent tests and they cannot be linked with each other on any parameter or fee benefit in any case.
- Decision regarding Scholarships, Fee Benefits, Due Dates of Fee Deposition, Course/Medium/Study Centre Transfer etc. are discretionary rights of Institute's Management.
- In a Two, Three or Four-year course, the scholarship provided shall be applicable for the first academic session's tuition fees (one year) only. The scholarship in the second academic session will only be provided on basis of student's academic performance of previous year. In this management's decision will be final.
- Scholarships/fellowship should be granted after submitting the valid documents by the candidates & eligibility as required by the management of the institute. In this management's decision shall be final.
- Any dispute at any Study Centre will be subject to Kasganj jurisdiction only.
- The right of awarding scholarship to any student reserves with AIIMSD. The institute may disallow scholarship to any student despite being eligible for it without assigning any reason. The students can not claim any right for this. For any issue, the jurisdiction of Kasganj (U.P.) shall be applicable.
- The student has to submit photocopy of an authentic document proving his/her eligibility to avail the disbursement of scholarship amount.
- If a student receives any of the rewards as mentioned above during the course period & if he/she decides to leave the institute/withdraw from the course/shows continuous/frequent absenteeism before the completion of course at any stage; the institute will have all the rights to recover the reward amount/any other financial expenses incurred from the student. This may involve legal proceedings; if required.
- A student eligible for the above scholarships Program may be denied or stripped off from the scholarship if his/her is published/declared in public domain by any other institute/organization as a classroom/distance learning/e-learning student to take the credit of his/her selection as part of its promotional strategy. The institute will have all the rights to recover the Scholarship amount/any other financial expenses incurred from the student. This may involve legal proceedings; if required.
- **The Scholarship benefits are always discretionary on the part of institute.**
